In response to the Affordable Care Act, some employers have looked into purchasing an employee-based health reimbursement arrangement (HRA) from a third-party carrier, as an alternative to the employer's plan. Although the ACA permits a self-insured employer to purchase an HRA for its small employers, a third-party HRA may be more costeffective for the latter. The purpose of this study was to identify the current HRA offerings for small and mid-size employers and to determine whether any of these HRA programs are positioned to thrive in the new health care marketplace. We reviewed United HealthCare and HealthSpring offerings for small employers in the United States and Canada, and selected a series of small employer offerings in the United Kingdom as a basis for comparison. The relevant data on each company's offering were collected from published sources, as well as from company websites and company communications. These data were gathered to characterize the offerings in the United States and Canada and to compare and contrast them with the offerings in the United Kingdom. Limited available data from the United States and Canada suggest that third-party offerings may become more prevalent as the ACA expands employer coverage. Although the United Kingdom offers many of the same benefits as the United States and Canada in the way of free access to primary care physicians and dental care for patients, the comparison indicates that the United Kingdom third-party offerings may be less extensive than those in the United States and Canada. Care must be taken in assessing any of these product offerings, as a small or midsize business may need to take a number of factors into consideration prior to making an investment in a third-party health plan.
